LIL DISH broke a bit slowly, saved ground while racing close to the pace, angled out at the top of the stretch, closed willingly and drew off in late stretch. BAR ROOM GAL stalked the pace outside, moved up to challenge on the turn, dueled to late stretch and was outclosed to finish second best. JACKSONVILLE set a pressured pace, inched away on the turn, responded to duel and faltered past the eighth pole. GUIDED WAVE lagged early, went seven wide in the drive and failed to rally. SEE EYE TO EYE fell far back early, improved position inside and was not a threat. COUNTY WEXFORD pressed the pace to the turn and gave way. COLD ROAR was not a factor. SEATTLE GAME stalked the pace, was checked on the turn and gave way.
