EQUIP showed the way to the lane and widened into midstretch then was kept to the task. REASONABLE EFFECTS raced just off the inside turning for home, moved to the rail in upper stretch and was second best. ONE FINE LADY prompted through the the opening stages, chased on the turn and weakened in the drive. HAVEUSEENMYDADDY forced out some at the start, was in the four path entering the lane and lacked the needed response. TOYON BAY moved out on the turn, was in the five path entering the stretch and lacked a bid. KATY'S COOKIN broke out, raced off the inside and tired through the lane. CHELOKETTE saved ground and weakened on the turn.
