### Footnotes

ALL SAINT saved ground and vied for the early lead, drew clear on the backstretch, showed the way to the lane and widened then held a rival safe under strong hand urging. GRANDPA ROY well placed while saving ground, chased through the lane and finished willingly while second best. DOUBLE SHUFFLE broke out slightly and brushed, trailed early, lodged a four wide bid on the final turn and lacked the needed stretch response. ELDAAFER just off the rail into the first turn, was asked on the final bend, moved inward and raced along the inside through the lane and lacked the needed response. RELATORRE pressed into the clubhouse turn three wide then settled in good position, continued in the three path to the lane and weakened. BRIARTIC COUNTY broke in and brushed at the start, raced rank and moved up between rivals approaching the clubhouse turn and vied rounding the initial turn, pulled while trying to be rated on the backstretch, raced just off the inside and tired in the drive.
