WINTER CANYON set the pace just off the inside, drew clear in the lane then held under mild hand urging. NICCOLO'S DANCER pressed early, saved ground to the lane and finished gamely for the place. PHARO'S GOLD pressed to the stretch from the outside then finished willingly while just missing the place. MODERN GENTLEMAN near the rail on the turn, drifted out some into the lane, came back in and lacked a rally. RIO DIABLO broke a bit slowly, moved outside on the backstretch, raced in the four path entering the lane and lacked the needed response. ATTENTIONTODETAIL saved ground and lacked a response then tired in the drive.
