ST PATRICKS APPEAL trailed early, saved ground and offered a late gain while missing the place. MOMMY GO TOO saved ground into the far turn, moved out and lacked the needed bid. WESTERN TWIST vied for the lead outside a rival and weakened through the lane. OCONEE three wide into the backstretch, raced forwardly placed into the far turn and weakened. BOLD ESSENCE lacked a response.
