VIKKILEE raced in the back, advanced inside around the turn, angled out for the drive, closed willingly, wore down her rivals, got up late and won going away. HAKUCHI (ARG) vied three across, went five wide entering the stretch, had the lead late and was outclosed. NENA'S NINER vied to late stretch, was unable to sustain her bid but held for show. DRAWING BREATH stalked the pace, was checked on the second turn, lacked room and was boxed in through the upper stretch and went willingly to the wire. SUN CITY raced mid pack, went six wide at the top of the lane and lacked the needed late response. WE ARE ONE vied between horses to mid stretch, weakened and faded from contention. DEE STORM failed to menace in an even effort under mild urging. SUNSHINE HIGH got through along the rail on the second turn, lacked room in the upper stretch, fell back and faded. CALIENTE ROJA was taken back at the start and trailed under mild urging.
