LOOKOUT COUNTY saved ground, angled out on the turn, swung wide, dueled past the eighth pole, drew off and drifted out. BOJOUR stalked the pace, was carried out at the top of the stretch, closed steadily and earned place. MAINY was unhurried early while racing outside, closed steadily and got up late for show. OBJECTION set a pressured pace, faltered past the eighth pole and lost position. BARELY BEEN KISSED gained late inside in a steady effort. CLASSIC JOURNEY pressed the pace, challenged for the lead on the turn, dueled past the eighth pole and faltered. CALI GAL was crowded at the start, got through inside on the turn and lacked a rally. BELLA JOURNEY had brief speed only. RUBYLONGSTOCKINGS trailed the field.
