P JS LIL TONI set the pace and extended her lead through the stretch while being kept to task. BLUE MOON HIGH broke out while away alertly, was pushed in at the gap, settle in the back, bid five wide and prevailed for place while no threat to the winner. PLAYMEAMELODI raced mid pack, advanced inside, awaited room on the turn, bid between horses and was outnodded for second. AUVERGNE bumped at the start, chased the pace, leveled off in the drive and fell back. BECKER COUNTY MISS saved ground, lacked a bid and failed to menace. PRAIRIE ACADEMY bumped at the start, went seven wide in the drive and failed to threaten. ROLLIN STOCK failed to threaten in an even effort. CANT CATCH JUDY raced close to the pace, went four wide entering the stretch and faded under mild urging. SO DIVINE broke out and bumped at the start, veered in at the gap, chased to the second turn, was checked sharply and stopped.
