BLAZE AND GLORY broke in and in good position early, was asked nearing the quarter pole and finished willingly while not good enough. RUNLIKEACHAMPION well paced and three wide into the lane, lacked the needed late response. TWO TURN GENERAL tracked early and between rivals into the far turn, lacked a response. ELEGANT VICTOR raced along the inside into the far turn and lacked a rally. CELESTIAL TOPPER raced four wide into the stretch and lacked a bid.
