WOLF COUNTY lunged a bit at the start, stalked the pace, rallied on the turn to challenge, assumed command and drew clear under urging. COSTAPLENTE fell back at the start to trail, swung wide on the turn, found his best stride late and was gaining ground. DOUGLASS broke awkwardly to be off slowly, raced outside, bid but didn't have enough late. THUNDER ALI raced close to the pace inside, bid off the rail to loom a threat, had little left and hung. RICK THE BARBER sprinted clear to set the pace to the turn, weakened in the drive and faded. RIO DIABLO raced inside, showed brief speed only and was not a threat.
