Footnotes

ILIKECHOCOLATEMILK was void of early speed, slipped through along the rail leaving the turn, closed inside, got up late and won going away. JOE BLACK SANDY chased the pace, advanced around the turn, eased out for the drive, bid willingly, dueled for the lead, led briefly and was outclosed. TONIGHT AT ELEVEN lunged at the start, was well placed, rallied around the turn, bid six wide to duel briefly but didn't have enough late. VICTORY CHECK was slow early, went seven wide entering the stretch and finished well. OCONEE sprinted clear to set the pace with a long lead, tired in the drive and fell back. STORMY SEATTLE raced mid pack outside, went six wide entering the stretch and offered a mild bid only. TONY THE PONY was not a factor. ST PATRICKS APPEAL raced in the middle of the pack, bid off the rail leaving the turn to get within striking distance but came up empty. RATON PASS was outrun.
