ALEXANDRIA MARIE was checked in traffic on the turn, moved out for the drive and closed well to win going away. LAKSHMIMAHAGANSM broke inward bumping a rival and causing crowding, raced three wide on the turn, vied for the lead then was no match late to the top one. NATURAL PEARL bumped and crowded at the start, advanced four wide on the turn and needed more late. OFFICER LUSK came out slightly and bumped leaving the gate, set the early pace off the rail, raced between rivals on the turn and vied for command then weakened in the drive. HOLY TRICK moved inside on the turn and lacked the needed stretch response. AUNT AMY bumped between foes at the start, moved up along the rail and challenged for the lead on the turn then tired in the drive. EMERALD'S DIAMOND bumped and in tight at the start, chased then was checked entering the turn dropping back. Following a claim of foul by the rider of NATURAL PEARL against LAKSHMIMAHAGANSM for interference at the start, the latter was disqualified from second and placed third. A stewards inquiry concerning the run entering the turn resulted in no further changes.
