**Footnotes**

UNBRIDLED FURY took the lead midway on the first turn, set the pace then was ridden out while continuing to widen. CARNERA settled in the middle of the pack, eased out turning for home, finished well and earned the place. WICKED LANDLORD was four wide down the backstretch, took the two path in the drive but was outfinished for the place. BIG CITY BERNIE forced the early pace, moved to the rail for the stretch but didn't have enough late. BEAR FAMOUS TRIP was four wide around the far turn and five wide into the stretch but lacked a rally. STAMP OF APPROVAL led into the first turn, then chased the winner into the far turn then tired. BATTLE SCHOOL was five wide on the initial turn, was six wide into the stretch but was not a factor. TOMMY AND BUSTER was four wide on the first turn, was five wide into the drive and tired.
