### Footnotes

LUX LUTHER pressed the pace, challenged for the lead on the turn, dueled to mid stretch, drew clear and was all out at the wire. FIRE TALKER lagged a bit early, rallied three wide on the turn, closed steadily, was wearing down the winner and gaining late. PASS MY GUITAR set the pace, responded to duel, was unable to sustain his bid but held safely for show. PERSWOON bumped and was squeezed at the start, raced within striking distance but lacked a late rally. SEANSOLBEAN raced mid pack in an even effort. SUNDEVIL BILL bumped at the start and again in the backstretch and failed to rally. EAGAN broke out and bumped at the start, pressed the pace inside to the turn and leveled off. BRITE BENTON bumped along the backstretch and trailed the field. The rider BRITE BENTON claimed foul against the rider of SUNDEVIL BILL for alleged interference along the backstretch. No change was made.
