TRAFFIC UPDATE vied for the lead then dueled the winner to deep stretch, was no match for that one but held the place. WESTERN WALLY settled off the leaders after the start, took the three path on the turn and into the stretch then finished willingly. BUCK'S BLUSH saved ground on the turn, stayed inside for the stretch but was not a factor. PEPPER DAN had his head turned over the gate, breaking far behind the field, then was declared a non-starter by the stewards with all wagers ordered refunded.
