Footnotes

FOREST MOUSE stalked the pace, eased out for the drive, closed steadily, drifted out under left handed urging and drew clear late. FOX IN THE HOUSE saved ground, angled out at the top of the stretch, closed steadily and got up for second. GREEN SECRET broke sharply, set the pace and faltered near the sixteenth pole. DYNAMIC RANGE was slow early, went seven wide at the top of the stretch and offered a mild bid only. LESSON IN DECEIT trailed the field, bid inside on the second turn and hung in the lane. EDGERIN J raced outside, went six wide at the top of the stretch and lacked a bid. ST PATRICKS APPEAL stalked the pace, swung wide leaving the turn, gave way and dropped back.
