### Footnotes

JOHN G C rated off the early leaders while four deep down the backstretch, remained four wide on the far turn, lodged his bid at mid stretch and drove clear late. FUSAICHI SAINT lugged out some into the first turn, was straightened while three deep down the backstretch, lodged his bid approaching the far turn, took a clear lead then was no match for the winner while clearly second best. WESTERN STRIDER moved into contention down the backstretch, remained in contention to the stretch and weakened. INDY ENDEAVOUR was between foes down the backstretch, raced four wide on the far turn and weakened in the drive. MY DIXIELAND MAN was well off the rail into the backstretch, was seven wide on the far turn then could only pass tiring foes in the stretch. REIGN OF THE EDGE settled after the start, was four wide into the stretch and never seriously threatened. MINERO DE ORO set the pace into the far turn responded briefly when challenged then tired in the stretch. THE QUEEN'S APPLE lugged out into the first turn then was not a factor. D P SPECIAL lodged a brief bid nearing the far turn, saved ground and stopped.
