Footnotes

FLEXIPLUS always a factor, moved to the front entering the backstretch the final time, showed the way to the stretch run then held gamely to the wire while drifting out late. PORFIDO (CHI) moved up four wide with a little over five furlongs remaining, bid three wide on the last turn and chased then finished willingly while being forced out slightly nearing the wire. LAYOVER IN SEATTLE saved ground and sat in a good position entering the final turn, stayed inside and chased through the lane then finished willingly while needing a bit more. FOX IN THE HOUSE moved with the eventual winner entering the backstretch the final time and prompted the issue, bid between foes on the last turn and chased then was not quite good enough. BLAST'EM saved ground early and just off the inside entering the far turn, moved three wide into the lane and lacked the needed late response. SUPER CANDY raced off the inside turning for home and lacked the needed rally. MATAMOR lacked a rally. STRATEGIST challenged for the lead entering the backstretch the final time then weakened into the far turn. MODERN GENTLEMAN saved ground and lacked a bid. RHYTHM IN MAY reared at the start to be off well behind the field losing his best chance. DONTWISEUPADUMMY was outrun. DISTANT RAINBOW opened a long lead through the initial half mile, remained well in front through the opening mile then gave way after ten furlongs and faded. A claim of foul by the rider of PORFIDO (CHI) against the winner for interference nearing the wire was not allowed
