DOC'S FU PEG broke sharply, vied along the rail, dueled through the stretch and prevailed in a game effort. RYAN'S AUDRINA vied three across, dueled through the stretch and prevailed in a game effort. EAST OF OMAHA raced close to the pace, challenged four across on the turn, fell back, continued willingly and held safely for show. TATE B vied between horses, had the rider check in tight quarters past the eighth pole and fell back. LA PRIETA LINDA raced mid pack, swung wide leaving the turn and offered a mild bid only. MASKED MARTINI saved ground, lacked a rally and was not a factor. MONTANA MO was outrun. FREAKIN FAST lagged while racing outside, lacked a bid and was outrun. Following a stewards inquiry, RYAN'S AUDRINA was disqualified and placed fourth for causing interference in the stretch.
