### Footnotes

OSO CATY was slow early, went ten wide entering the stretch, closed steadily, got up late and won going away. GILMORE broke slowly, lagged outside, bid nine wide and got up at the wire for place. GADSDEN PURCHASE pressed the pace between horses, fell back into the turn, came again seven wide, dueled, had the lead late and was outfinished. ALL OUR LASS vied to the upper stretch, veered in and leveled off. SWISS ENGAGEMENT improved position in an even effort. YOUBETSHEWON vied inside, was intimidated in the upper stretch, came in and stopped. PINE RIDGE stumbled at the start, lacked a bid and was outrun. IMA ROYAL PRINCE raced outside, showed brief speed and dropped back steadily. STORMDRIVER clipped heels, fell and lost his rider. Following a stewards inquiry, YOUBETSHEWON was disqualified and placed last for causing interference in the upper stretch.
