POHAKU well placed early, lodged a three wide bid on the final turn, reached the front in the stretch and held gamely to the wire. DISTORTED SKY was steadied slightly inside heading into the clubhouse turn, raced four wide while lodging a bid nearing the quarter pole and finished gamely. HEADS UP PENNY tracked early, was asked on the final turn and pressed the issue into midstretch then was not good enough. TWO ONE GUN set the pace inside and weakened in the drive. CANNONVILLE lacked a rally. MARION'S CHOICE trailed early and outside turning for home, lacked the needed rally. MEDICINE HAT chased early and weakened through the lane. NORTH DREAMER chased early and gave way on the final turn then faded through the stretch. A claim of foul by the rider of DISTORTED SKY against the winner for interference into the clubhouse turn was not allowed.
