RUNNING RACHIE showed the way to the lane, responded when asked to widen then was ridden out. CUTLER was steadied into the turn, chased three wide on the bend, was five wide entering the stretch and was second best. GUZZLE N GO moved inside on the turn and was best of the rest. FORTYFIVEJEWELS broke in some, raced along the inside through the stretch and lacked the needed rally. LOVELY LUCINDA got out heading into the turn and was steadied, chased just off the inside, drifted out into the lane and tired. MS WICKENBURG was steadied and bumped nearing the turn, chased outside and tired through the stretch. SIPPIN COCOA in tight at the start, raced wide while getting out on the turn. BROOKE'S SILKY fractious briefly at the gate, broke out then showed little. A claim of foul by the rider of MS WICKENBURG against CUTLER for interference heading into the turn was not allowed.
