LYNNE LOUISE bumped at the start, held a good position, closed willingly and won going away. LOVELY TOSS bumped at the start, raced close to the pace and lacked the needed late rally. CONCERTED lacked early speed, rallied late and got up for show. ED'S IN EXCESS set the pace, faltered near the sixteenth pole and was erratic in the late going. T T TIGHT raced mid pack while within striking distance, bid along the rail on the turn and hung. CLIENT STATES put in an even effort and failed to rally. STRIKE DIAMONDS broke out and bumped at the start and had brief speed only. SAUCY DISPUTE broke in and bumped at the start and failed to contend.
