ARRAIGNMENT stalked the pace in hand, was boxed in into and around the second turn, angled in, got through along the rail, dueled for the lead and inched away to prove best. QUAIL HILL set a pressured pace, dueled through the stretch but couldn't match strides with the winner. LISTEN YOU FOOL raced close to the pace, rallied four wide on the turn and lacked the needed late response. CANAL GRANDE lagged outside, went five wide entering the stretch, bid and hung. DE SO LONG COWBOY pressed the pace two wide to the second turn, leveled off and faded from contention. BRO DEREK broke awkwardly, raced in the back, lacked a bid and was not urged late.
