TRIAL BY JUDGE dueled for the early lead and finished steadily while edging clear. PARLAY'S DEE saved ground and vied for the early lead then held on well in the drive. SILVER REVIEW just a bit fractious in the gate, raced outside into the lane and was gaining some late. DARK STARLING well placed early from the outside, lacked the needed stretch response. COOL CHERRI close up early, raced just off the rail on the turn and weakened. WALK WEST bobbed to be away awkwardly dropping back then lacked a rally.
