### Footnotes

EL RANCHO set the early pace, saved ground and vied for command turning for home then responded to strong right handed pressure to prevail. R SKYDIVER up close early, moved to a narrow advantage passing the quarter pole then continued on willingly while being outfinished by the top one. FAST FREIGHT bumped at the start and inside early, eased out in the run to the turn, advanced three wide on the bend then lacked the needed stretch response. CACTUS BREEZE outrun early, raced in the three path into the lane and offered a mild response. VALLEY STATION pressed the early issue, saved ground and weakened in the drive. SUPERCARLS REMEDY up close early between rivals and steadied some into the turn, raced in tight briefly between foes on the bend then lacked the needed stretch response. MODERN GENTLEMAN raced near the rail on the turn and lacked a bid. FOREST SOUNDS ducked in soon after the start and steadied, came wide to the stretch and lacked a rally. SALADO TRIBE outside into the turn, advanced some then raced four wide into the stretch and tired. PREACHER'S THREAT was steadied along the inside entering the turn and dropped back.
