WINNING WEAVE raced in the two path turning for home, was along the inside through the stretch run and also finished gamely. CRYPTO 'N CRUISE raced wide turning for home and gained some late. OFF MY CASE well placed and outside on the turn, lacked the needed stretch response. LIL CELESTE raced near the inside on the turn and lacked a bid. NOT A BULL chased inside and tired in the drive. LOOKIN TRICKY chased between and weakened through the lane. FIRST MARTINI was pulled up on the backstretch then vanned off.
