GOING TO REHAB set a pressure pace to the lane, drew clear then held a rival safe to the wire. RUTHLESLEE fractious at the gate, lodged a three wide bid on the turn and finished willingly. MYSWEETGUARANI moved out in front of a rival into the lane and chased then needed more. BELENUS moved four wide turning for home and was steadied slightly entering the lane then lacked the needed rally. STELLA'S LIONHEART raced just off the inside into the stretch and lacked the needed bid. I'M A LITTLE KINKY fractious at the gate, pressed the issue from along the inside and tired in the drive. HIGHEST BIDDER reluctant loading, broke a bit awkwardly, raced five wide into the stretch and tired.
