AGAINST THE LAW vied for the early lead, saved ground turning for home and drew well clear into midstretch under left handed pressure then drew off under hand urging. BLUESKYCAT four deep and between rivals passing the half mile pole, moved up and loomed a solid threat on the turn then weakened late while holding the place. ASURASLEW raced three deep and between foes approaching the turn, raced just off the inside into the lane and was gaining some late while just missing the place award. OUR LITTLE PASSION saved ground into the turn, moved out and lacked the needed stretch response. DANCE CRUISE saved ground and pressed the early issue then weakened through the stretch. SIZZLIN EASY pressed early five deep and weakened on the turn. ROYAL RIVELY broke out and lacked a response. THUNDERHIT ducked into the gap leaving the gate and lost the rider. The stewards posted the inquiry sign concerning the start prior to declaring the original order of finish official.
