LYNX LAKE fractious loading, set the early pace just off the inside, lost the lead nearing the quarter pole then battled back to prevail. DEPUTY INNOVATOR came in soon after the start bothering rivals, reached the front along the inside nearing the quarter pole, drew clear in the stretch then yielded at the wire. RAMBLE ON ROSE pressed early from the outside, drifted out some turning for home then held the show. LIDGES SLIDER moved wide turning for home and chased then lacked the needed late response. MAGGIEREDVANENTUNE broke out then was checked when forced into the gap soon after the start dropping well back. RIGGS FLAT broke in then a bit rank, was also checked when forced into the gap soon after the start and was no factor thereafter. TASTE THE WILD chased early, was steadied into the turn and dropped back. BUCKS SAGA chased early and weakened. ROAD ORPHAN was steadied when forced in soon after the start, raced off the rail on the turn and tired. Following a stewards inquiry, DEPUTY INNOVATOR was disqualified from second and placed last for interfering with rivals soon after the start.
