RENEGADE CIELO advanced between rivals soon after entering the turn, challenged for the lead along the rail in midstretch and finished well while edging clear. WEST FORTY vied for the lead inside, raced in the two path entering the lane and battled for command then could not match strides late with the top one. YOUNIQUE CAT up close early and five wide, chased four deep on the turn, was five wide again entering the lane and finished willingly. PURR FOR ME up close early and between rivals to the turn, raced six wide into the stretch and lacked the needed late response. ARRIVEE ARRIVEE raced eight wide into the lane and offered a mild bid. SWEN RAY vied early, raced between rivals and weakened in the drive. SNARK raced seven wide and between foes turning for home and lacked a rally. REPORTERS DREAM chased early, raced six wide turning for home and lacked a stretch bid. QUICK VIC pressed early four wide, was three deep on the turn and tired in the drive. I BEAT THE FIRE saved ground and lacked a bid. CITY VENTURE broke slowly, saved ground and lacked a rally. DEEP CREDENTIALS raced near the rail and lacked a bid.
