

QUEEN RAZYANA prompted the issue down the backstretch, moved closer turning for home, drifted in some leaving the furlong grounds then finished well and drew clear while drifting out late. ROYAL CHEER never far back and four wide entering the lane, finished gamely for the place. BLUMIN BEAUTY set the pace, saved ground to the lane, battled heads apart into midstretch, was steadied some nearing the sixteenth pole and eased out slightly then was outfinished late for the place award. PRINCESS MCLEAN hung just a bit wide into the clubhouse turn then rank rounding the initial bend, settled close up, raced three wide turning for home and lacked the needed stretch response. LATE DATE was asked for run outside on the final turn and lacked the needed stretch response. IRISH FERRY came in some at the start, raced near the inside turning for home and lacked the needed rally. HOLY FASHION vied for the lead through the opening stages, saved ground while close up and lacked a stretch response. OLIVER THE MOON in a bit close leaving the gate, raced outside into the lane and lacked a rally. RESTRIDE saved ground and lacked a response. LA COYOTE saved ground and lacked a bid. The stewards posted the inquiry sign and the rider of BLUMIN BEAUTY lodged a claim of foul against the winner for stretch interference but no change was made.
