COUNTY WEXFORD bumped at the start, pressed the pace, took command on the turn, bumped repeatedly in late stretch while dueling and prevailed in a game effort. SHOT FOR GRANDMA broke in and bumped at the start, pressed the pace, challenged for the lead on the turn, bumped repeatedly in late stretch while dueling and was outnodded to just miss. EASTER HIGH raced outside, went six wide in the drive, closed well and was all out for show. SPEAK FRANKLY raced outside, went seven wide in the drive, closed well and was outfinished for third. SHAMUS ON ME pressed the pace while racing inside, fell back on the turn and hung in the lane. COUNTESS CAPOTE broke a bit slowly, lagged, offered a mild bid only and failed to menace. RIO BRILLA set the pace to the turn, weakened and faded from contention. CANONITA flashed speed, dropped back and had no further response. URA STAR was not a factor. PERHAPS PERHAPS stumbled at the start and lost her jockey. The stewards' posted an inquiry regarding the start of the race. No change was made. The trainer and rider of SHOT FOR GRANDMA claimed foul against the rider of COUNTY WEXFORD for alleged interference in late stretch. No change was made.
