Footnotes

ESTANCIA vied to the turn, drew off for a long lead and held safely while being kept to task. TRIFECTA PHIL raced close to the pace, went four wide entering the stretch and got up for place while no threat to the winner. CITIZENS BRIGADE vied inside to the turn, fell back, went evenly late and was outfinished for second. CONDITIONAL stalked the pace while racing inside, fell back entering the turn and had no further response. JOE'S CANNON raced outside, went seven wide in the drive and offered a mild bid only. ALL TRUE improved position in an even effort. SUMMER SNOW showed good early speed, dropped back, went six wide in the drive and continued to fade. RIBOMOON was not a factor. WARREN'S BLVD. had brief speed only. MAGAZINE LANE was outrun.
