Footnotes

AGGRESSION rallied four across on the far turn, got a head in front, inched away for a short lead and held in a driving finish. DISTORTED SKY was unhurried early, rallied five wide on the second turn, closed steadily but didn't have enough late. VEGAS TRAIL was never far off the pace, rallied four wide on the second turn, bid willingly to loom a threat and hung late. DOLLAR FACTOR raced close to the pace, challenged three wide between horses on the turn, dueled to mid stretch and faltered. RON BOB pressed the pace while racing inside, got behind a tiring rival on the turn, fell back, shifted out, continued on, bore out under left handed urging in the stretch and failed to gain. CASA MIA was slow early, offered a mild bid only, was carried out and impeded in the drive and fell back. SUNSET KID broke a bit awkwardly to be off slow, lagged, was carried out and impeded in the stretch drive and did not threaten. DUBAI RAMBLER chased the pace, challenged between horses on the second turn and gave way. A P APTITUDE set the pace to the second turn and tired. BUCK'S STRIDE was through early and not urged. Following a steward's inquiry, RON BOB was disqualified and placed seventh for causing interference in the stretch drive.
