COUNTRY ESTATE set the early pace, saved ground and lost the lead on the turn, dueled through the lane and held gamely to prevail. MAZZY raced four wide turning for home and finished gamely. ATTACK MODE advanced on the turn and reached the front, dueled through the stretch then was not quite good enough. ZENA'S A WARRIOR up close early, chased through the lane and needed more. CAPALATTE between foes into the turn, chased and also needed more. ISAGIA MIA raced in the four path into the stretch and lacked the needed rally. l'llTAKEACHANCE lacked a bid while six wide into the lane. PRINCESSOFOTHERING up close early, saved ground and weakened in the drive. A CASE OF GOLD LUC lacked a rally. GOLONDRINA chased early and tired. HOLD THE RANSOM was eased turning for home and vanned off.
