TEJANO TROUBLE advanced on the turn and reached the front in upper stretch then drew out under mild hand urging. CLASS FIVE RAPID broke in, moved three wide turning for home and finished willingly while second best. DUKE DELUXE chased early, raced between rivals on the turn and weakened in the drive. CITY VOW saved ground to the lane and lacked the needed rally. SLIDE ROCK raced six wide into the stretch and lacked the needed response. COLD SURF set the pace inside and weakened in the drive. DINNER AT JAKE'S trailed early and near the rail turning for home, lacked a rally. NO LAUGHING MATTER chased early, raced five wide into the lane and tired. GENTLEMAN LAWYER chased and weakened in the drive. LORD VIC raced in the four path into the stretch and offered little in the drive. TARAGE bumped at the start, saved ground and lacked a bid. SECTION F stayed outside, was six wide into the lane and lacked a bid.
