BRIARTIC COUNTY veered in a bit at the start, set the pace, responded to pressure on the turn, drew off and held safely under left handed urging. GREEN SECRET stalked the pace, challenged three across on the turn, fell back, failed to gain and finished second best. FEEL THE MOMENT saved ground to the second turn, eased out, bid six wide and was along for show. DON'T DEFY ME was away well to stalk the pace, challenged between horses on the turn, fell back and finished evenly. LESSON IN DECEIT was slow early, offered a mild bid inside and improved position. GATLING GUN failed to threaten in an even effort. MR. WINDSOR saved ground mid pack, lacked a stretch response and was not a factor. FOX IN THE HOUSE was not a factor. IRON FORTITUDE was outrun.
