DESERT SEA bid along the rail on the second turn, angled out to challenge for the lead, dueled to mid stretch, drew away and was all out at the wire. FAVORITE MEETING lagged early, rallied four wide on the second turn, found his best stride late and was gaining ground. RENEGADE CIELO set a pressured pace inside, drew clear on the far turn, weakened in the drive but was clearly best of the rest. POWER STROKIN raced mid pack off the rail, lacked a rally and was not a threat. CANDI'S TOAST pressed the pace between horses to the second turn and tired. BUZZ THE TOWER pressed the pace three wide to the second turn and gave way. FIERCE CAT trailed the field.
