SLYLY in tight into the turn, moved three wide into the lane and finished gamely while prevailing at the wire. TRICKY LINDA up close early, lodged a three wide bid on the turn, reached the front nearing the wire then just missed. HOT BY ASSOCIATION pressed the issue, reached the front briefly a sixteenth out then was not good enough. HUMBLE SUSPECT broke out, set the pace inside and weakened in the drive. CU AT SUNUP was steadied in tight into the turn then lacked the needed rally. BRITE NAVY in tight into the turn, chased and lacked the needed stretch response. ZENA'S A WARRIOR lunged out at the start, moved inward heading into the turn, chased and tired in the drive. BEHRENS AFFAIR raced five wide turning for home and weakened. ZAREE saved ground and lacked a bid. DASHING VIXEN broke slowly and lacked a bid. BOJO JANGLE stayed outside and chased into the turn then tired. YAKKITY ZAK just a bit reluctant loading, was away a awkwardly then lacked a bid.
