TASTE THE WILD held a clear advantage to the lane then responded to pressure and edged away. DOUBLE TRICKSTER chased on the turn and finished steadily while second best. LIKABLE LADY chased inside and weakened in the drive while holding the show. NORTHEAST ABBIE raced five wide into the stretch and offered a belated gain. YANG bothered some at the start dropping back, was four wide turning for home and offered a belated bid. YING broke slowly and inside into the turn, moved out into the lane and lacked the needed response. LET'S DO THIS off the inside into the turn, raced near the rail into the lane and lacked a rally. BUCKS SAGA chased and weakened in the drive. SWEETCOTTONKANDIE chased and tired in the drive. SEA SPLENDOR broke out chased into the turn and weakened then faded through the lane. ANNAPOLIS FLYER stumbled badly at the start unseating the rider. The stewards posted the inquiry sign concerning ANNAPOLIS FLYER prior to declaring the original order of finish official.
