**Footnotes**

LANG FIELD set a pressured pace, dueled in late stretch and held on gamely to prevail. WARREN'S ALLSTAR was allowed to settle, saved ground, bid along the rail on the turn, dueled in late stretch and was outnodded to just miss. ROGUE RIVER pressed the pace inside, was taken off the rail, angled out into the turn, swung wide entering the stretch and offered a mild bid only. GROW UP stumbled at the start, pressed the pace between horses, weakened in the drive and faded from contention. BALLESTERRO raced close to the pace, moved up along the backstretch to challenge three across, fell back at the top of the lane and faded through the stretch. SANQUINE stumbled badly at the start to be off very slowly and trailed the field while not being asked. WHITNEY BRIDGE pulled up and was walked off.
