RAINIER MISSILE moved up along the inside and reached the front nearing the turn, showed the way to the lane and drew well clear into midstretch then responded to urging and maintained a clear advantage. AMBEKAY lodged a four wide bid on the turn, raced in the five path entering the lane and finished willingly while second best. PAYMENT APPROVED chased on the turn three wide, moved inward passing the eighth pole and offered a mild response. BEALE STREET chased and just off the inside on the turn, weakened in the drive. SAN DARINO stumbled badly at the start dropping back, saved ground and lacked the needed response while lacking a clear path inside the eighth pole. LOCKSLEY HALL chased three wide on the turn, raced in the four path entering the lane and tired. EXPECT ME was outrun and distanced through the lane. Following a stewards inquiry, PAYMENT APPROVED was disqualified from third and placed fifth for stretch interference.
