**Footnotes**

LESSON IN DECEIT unhurried early, lodged a six wide bid turning for home and finished well while drawing out. BOURBON SHOOTER saved ground into the far turn, raced between rivals into the lane and earned the place. TASTE OF BATTLE set the pace inside and weakened late. GLENWICK well placed and four wide into the lane, lacked the needed response. JAKEONTHERUN five wide early, stayed outside and came five wide into the stretch and lacked the needed bid. ST PATRICKS APPEAL angled inward into the clubhouse turn, tracked and weakened in the drive. MANSIONES saved ground while well placed and tired in the drive. EPICURUS raced in the three path turning for home and lacked a bid. LADNER LAD four wide early, weakened entering the far turn.
