**Footnotes**

DUNSCOMBE was never far off the pace, went six wide leaving the turn, surged late and got up in the final strides. CANARD set a pressured pace, inched clear leaving the turn and was caught near the wire. ADVICE pressed the pace, fell back on the second turn, went evenly late and just held for show. KWIK stalked the pace, offered a mild bid only and was outnodded for third. BEARS HOME RUN lagged outside, went six wide entering the stretch and lacked the needed late response. UNBRIDLED FURY bobbed, broke awkwardly, was in tight on the first turn, raced in the back and lacked a bid. DRAW failed to threaten in an even effort. JACK ATTACK raced mid pack while saving ground, weakened in the drive and faded.
