AZA vied for the lead throughout, responded to repeated challenges and held on gamely at the finish. GRANDPA ROY saved ground on the far turn, stayed inside to loom a threat into the stretch, lodged his bid along the rail and just missed. HIS WAY was well placed off the dueling leaders, lodged his bid in upper stretch then threw his head inside the furlong marker and held on well to the finish. TAKEITTOTHEBANK was four wide moving up on the far turn, remained four wide into the stretch then lacked a solid late bid. REPETOIRE was in contention into the far turn then dropped back some and went evenly in the drive. NAUTICAL CANDY vied for the lead and was in contention to upper stretch then weakened. WIN TO THE END was steadied between foes into the first turn and was shuffled back then didn't threaten. FIERCE CAT moved into contention while three deep nearing the far turn then lacked a further response and tired. A jockey and trainers objection by the third place finisher against the winner for stretch interference resulted in no change
