T J AND COMPANY broke awkwardly and was crowded at the start, rallied four wide into the stretch, closed steadily to wear down I'M THE GOLD and got up late. I'M THE GOLD broke out, set the pace, held a clear lead, led to the final strides and was outclosed in a game effort. PROFITABLE was unhurried early, went eight wide entering the stretch and finished well to get up for show. AFLEET BUD was never far off the pace, went five wide entering the stretch and offered a mild bid to narrow the gap. CALL FOR JUSTICE was void of early speed, bid between horses on the turn but didn't have enough late. HUMBOLDT NATIVE stalked inside, eased out on the turn, bid and hung. SIX DAY JOURNEY stumbled at the start, swung wide leaving the turn and lacked the needed late response. AWESOME TOCCET hesitated at the start, bid three wide between horses on the turn and came up empty. SILVER DAYBREAK showed good early speed, was rated around the first turn, dropped back, went eight wide in the drive and did not threaten. FLASH OF LIGHT broke out, raced in the middle of the pack in an even effort and lacked a bid. GELFAND pressed the pace to the second turn and stopped.
