FANCEY ENDEVOR chased on the turn and loomed a solid threat to the top one then was no match while clear for the place. TEN THOUSAND LAKES saved ground and offered a mild stretch response. PRAIRIE ECLIPSE up close early, chased inside through the lane then tired. CELESTE MARY lunged out at the start, chased outside and tired in the drive. MIDKNIGHT MATTY came six wide to the stretch and lacked a rally. JARETT'S FOOL raced five wide into the lane and lacked a bid. JOLIVA DEVINE pressed early and tired through the lane. MELODIA well placed early, raced near the rain into the lane and weakened. TICKLEMETERRELLMO lacked a rally. ANUNDENIABLYHAPPY chased early and dropped back on the turn then was pulled up in distress and vanned off. TASTE OF JOY was pulled up entering the turn and vanned off.
