BOCALLI set the pace in hand to the stretch, responded when asked and drew clear late. CONSIDERATE SWISS forced the pace of the winner, was asked nearing the stretch then was no match for that foe but held the place. WARREN'S CANDY settled after the start, stayed inside for the drive and lacked a solid bid. SLEW LA LA tried to rate around the first turn into the backstretch, took the two path in the stretch and lacked a late bid. ENTREGADA settled after the start, took the three path into the stretch and tired. PEPE LE FEU was five wide into the stretch but was never a serious factor and tired. LO RISQUETTE was four wide into the first turn, remained four wide into the stretch and tired.
