LET'S DREAM AGAIN drew clear on the clubhouse turn and widened down the backstretch, showed the way to the lane and remained well clear under some stretch urging. PERSONAL REGARDS well placed and outside a rival turning for home, finished steadily and was clear for the place. HAMMETT STAR raced along the inside into the far turn then offered a mild late bid while earning the show. MAJAKAT tracked early, saved ground and lacked the needed response. ROLLIN STOCK moved out on the final turn then offered a mild late response while finishing inside. NIPSY REAL JOY raced along the inside turning for home and lacked the needed rally. GLENDIVE raced off the inside and lacked a response. LEGACY NORTH saved ground and weakened rounding the final turn. GRAY HARE began buck jumping soon after leaving the chute and unseated the rider. The stewards posted the inquiry sign concerning GRAY HARE prior to declaring the original order of finish official.
